 - i. Isaiah Ball Chief Justice Appointment (President Hinojosa 5 minutes)

 - a. Senator Ewing asked if Isaiah Ball will be able to accommodate his class schedule with future Senate meetings
 - b. Isaiah Ball answered by ensuring that his schedule will not collide with Senate Meetings
 - c. President Hinojosa clarified protocol for discussion to be conducted by asking President Hinojosa questions about the candidate first, and if she can't answer, then the question is directed to the candidate
 - d. Senator Ewing asked Isaiah Ball if he'll be able to balance the diverse personalities of Senate members

- a. Senator Perez asked how Kirone Brown reached to Student Government
- b. President Hinojosa relayed that Student Government representatives reached out to Kirone Brown first, because he had prior experience/knowledge of Student Housing Government, and showed an interest for Student Government after President Hinojosa explained what Student Government does for CI
- c. Senator Perez asked if Kirone Brown chose the position of Senator of Housing and Residential Education
- d. President Hinojosa clarified that once Kirone Brown showed interest to help with Student Government, Student Government recommended the position of Senator of Housing and Residential Education
- e. Senator Ewing asked how Kirone Brown will like to spend the student fees on events
- f. Kirone Brown recommended to spend student fees on student wants/recommendations by reaching out to students via Club Echo
- g. Senator Ewing asked what Kirone Brown thought is the biggest problem in housing at the moment
- h. Kirone Brown said air conditioning is a big issue, because during the summer the temperature is very hot during heat waves
- Senator Federis asked if Kirone Brown has any ideas on how to improve student inclusion
- Kirone Brown suggested to uplift student's spirits through building faculty and student relationships
- Senator Lincoln asked how Kirone Brown will improve marketing in housing
- I. President Hinojosa suggested that Kirone Brown should reach out to Student Government for help
- m. Kirone Brown relayed that he will reach out to commuter students in the library, and market through social media and email.

- iii. Sarah Krashefski Director of Operations Appointment (President Hinojosa 10 minutes)
 - I. Motion to approve: Senator Perez
 - 2. Seconded this motion: Senator Christopher
 - 3. Discussion:
 - a. Senator Ewing asked how Sarah Krashefski will deal with difficult situations in Student Government
 - b. Sarah Krashefski relayed that communication is the key when analyzing how to communicate during difficult situations with diverse personalities. She also said that discussion-based interactions are best suited for deescalating miscommunication.
 - c. Senator Perez asked if Sarah is adequately prepared for her responsibilities
 - d. President Hinojosa expressed that during her first meeting with Sarah Krashefski, she observed that Sarah Krashefski had a clear understanding of what is asked of the position and is confident Sarah Krashefski will perform well under the required hours.
 - e. Senator Christopher inquired how Sarah Krashefski was recruited
 - President Hinojosa relayed that Sarah Krashefski was not referred directly to Student Government, but found the job posting online and applied
 - g. Senator Federis inquired about Sarah Krashefski's current involvement with CI View and the English Club and how she will manage all roles
 - h. President Hinojosa relayed that the Director of Operations position is a paid position, and feels confident that Sarah Krashefski should be able to time manage her position with other current leadership positions
 - i. Sarah Krashefski informed that she is not actively contributing to the CI View, but is currently the President of the English Club. Sarah Krashefski relayed that due to a cut down in hours contributed to the English Club, she will be able to time manage both roles appropriately
 - j. Senator Christopher asked what attracted Sarah Krashefski to the position
 - k. Sarah Krashefski expressed that she was attracted to the Director of Operations position due to the leadership, organization, and communication elements
