- i. CSSA Update (President Hinojosa 25 minutes)
 - I. President Hinojosa updated the Senate about CSSA.
 - a. President Hinojosa sent out an email to the Senate and asked for feedback.

- i. President Hinojosa educated about a potential program on CSU campuses that gives additional resources to students who were previously incarcerated called project rebound.
 - I. President Hinojosa asked the Senate if this program applies to CI's student body?
 - a. President Hinojosa voted in favor of this program, because students who participate in the program have high graduation rates
 - b. President Hinojosa relayed that project rebound has been consistently discussed in CSSA for several years, due to data.
 - c. The Senate discussed the benefits of project rebound, and asked questions about how it will be structured. President Hinojosa answered all questions and relayed that this program will be offered to students enrolled at CI who were incarcerated, and it will be structured similarly to the Multicultural Dream Center.
 2. President Hinojosa referenced legislation that was also sent in her email. President Hinojosa asked for feedback on voting for the bills from the Senate via email.

 - b. Vice President Mumford added that last year's Brunch included record keeping of students' questions to hold President Beck accountable.
