# VII) Special Presentations (85 minutes)

- A. Police Body Cam (Chief Morris 25 minutes)
  - i. Chief Morris presented about the new body cameras that will be implemented starting June 2018. Each officer will have a body camera and a new taser.
    - 1. Vice President Mumford asked Chief Morris if there will be an informational campaign to inform students
      - a. Chief Morris relayed they will use social media and MyCI but will not be giving public announcements.
      - b. Vice President Mumford expressed that the news center and email notification on campus is a recommended form of communication.
    - 2. Member of the public Noelle Ewing asked if the body camera will be active at all times.
      - a. Chief Morris relayed that the camera will only be active when the officer is on a call or investigating. The camera will not be on at all times due to privacy. The camera will also be activated when the officer's taser is in use. There is a red LED light that will flash to indicate recording.
    - 3. Senator Federis asked if the cameras are equipped for the rain and will stay activated when they are wet.
      - a. Chief Morris reassured that the camera is durable and will stay active in the rain.
    - 4. Vice President Mumford recommended that the CI Police include information about how the camera works on their website.

- 5. President Hinojosa recommended that the CI Police creates an informational video to post on social media.
- 6. Senator Brown recommended that the CI Police include the benefits of the body camera when they inform the study body.
- B. Microagressions (Motoko Kitazumi & Hiram Ramirez at 10:00 A.M., 60 minutes)
  - i. Presenters Motoko Kitazumi & Hiram Ramirez introduced themselves and let the senate know that this should be an interactive discussion.
  - ii. Everyone in the room stated their name, preferred pronouns and one interesting thing about them.
  - iii. Senator Lincoln asked what the best way is to ask for genders on a survey, for example: male, female or non-binary.
    - Hiram Ramirez recommended to have male, female, and other options where people can write in answers. In addition, the researcher can look up different identities and include those as options.
    - 2. Senator Federis asked if there is a list of different gender options.
      - a. Hiram Ramirez answered no since gender options are constantly evolving.
    - 3. Senator Federis asked about options given while doing research.
      - a. Hiram Ramirez recommended that the researcher should give more options because it allows those people to have a voice, however he understands researchers may be looking for specific answers.
    - 4. Hiram Ramirez talked about different ways that researchers look at data, sometimes comparing people of color to white and other times comparing a specific group to the majority of people in the study rather than white; these different ways of looking at research depends on the outcomes the researcher is looking for.
  - iv. Hiram Ramirez encouraged everyone to continue to think about this topic, how it affects ourselves, our peers and at Channel Islands in general.

    - i. Senator of Social Justice Appointment Juanpaulo Quiatchon (President Hinojosa 15 minutes)

- 1. President Hinojosa expressed that Juanpaulo Quiatchon showed interest in a Senate position. President Hinojosa asked Juanpaulo Quiatchon various questions about his knowledge about Student Government and how a Senator position represents their continuants during their interview. Juanpaulo Quiatchon relayed that he is interested in speaking with the student body and the Multicultural Dream Center. Juanpaulo Quiatchon is also willing to learn, especially from the current senators who are serving Student Government. Juanpaulo Quiatchon is not a graduating senior, he will be graduating in Fall 2018.
  - a. Motion to approve discussion: Senator Brown
    - i. Seconded: Senator Federis
  - Senator Federis asked about a bio questionnaire question, specifically pertaining to Juanpaulo Quiatchon's experience with facilitating open forums. (Bio questionnaire was sent out by email by President Hinojosa).
    - President Hinojosa relayed that Juanpaulo Quiatchon doesn't have experience holding discussions with students from different viewpoints.
    - ii. Juanpaulo Quiatchon relayed that he was involved in a discussion at the Republicans club and the discussion was conducted with respect even though they were discussing controversial subjects.
  - c. Senator Perez asked what Juanpaulo Quiatchon's opinion on the largest social justice issue at Cl.
    - President Hinojosa and Juanpaulo Quiatchon relayed food insecurity.
  - d. Senator Nguyen asked what Juanpaulo Quiatchon's topic is for public forum.
    - i. Juanpaulo Quiatchon relayed that he would like to talk about the Fourteenth Amendment and leave it open to discussion.
  - e. Senator Lincoln asked about Juanpaulo Quiatchon's experience with working with students with food insecurities.
    - i. President Hinojosa relayed that this new to Juanpaulo Quiatchon.
  - f. Senator Brown referenced the recent Walk Out and asked if Juanpaulo Quiatchon will be able to speak on behalf of minorities.
    - President Hinojosa relayed that Juanpaulo Quiatchon has no experience.
  - g. Juanpaulo Quiatchon relayed that CI has a diverse student body and viewpoints that he will try to represent to the best of his ability.

- h. Senator Nyugen asked Juanpaulo Quiatchon how we would jump start an public forum.
  - i. Juanpaulo Quiatchon relayed that he would ask for help from his fellow Senators. Juanpaulo Quiatchon would also like to conduct the public forum in a formal setting.
- Senator Perez relayed that he admires Juanpaulo Quiatchon's effort by getting involved but feels as though Juanpaulo Quiatchon needs more experience.
- j. Senator Lincoln relayed that since Juanpaulo Quiatchon doesn't have prior experience with working with social justice continuants, then he wouldn't be the best fit since we are limited on time for Spring 2018.
- k. Senator Christopher relayed concern for Juanpaulo Quiatchon communication skills. Specifically speaking on behalf of his continuants.
- Vote to approve Juanpaulo Quiatchon for the Social Justice Senator position.
