- a. ACTION ITEM: Bylaws Amendment (S. Ruiz)

This amendment would allow the Chief Justice to delegate their power as the Senate Parliamentarian, with the approval of the Vice President, to another Justice if they cannot attend a Senate meeting.

- a. Voter Registration Training (B. Patterson)
  - i. Betsy Patterson, the President of the League of Women Voters of Ventura County, presented a Voter Registration training session to the Senate. Explained the types of identification needed to verify citizenship, common questions asked when registering, and common issues that occur while registering. Shared that people can check online if they are not sure if they are registered to vote.
- b. Basic Needs Collaboration (A. Milanowski)
  - i. Alicia Milanowski shared her work on the Basic Needs Initiatives. Channel Islands will be part of a National Movement, November 13-16<sup>th</sup>, the National Hunger and Homeless Awareness Week. Discussed potential collaboration with Student Government and the Veterans Center. Possibly a panel discussion that week, comprised of whoever the students think should discuss the issue. Has been working with PATH, there are students who are willing to speak at panel discussion. Working on a possible display of what homelessness looks like for students, passive demonstrations with statistics. Possible guest speaker, Channel Islands alum Jay Wilkin
