    - i. Senator of Student Engagement (*J. Guajardo*)
      1. Held their office hour with Russell Winans to discuss club and organization matters; on November 16 an email was sent out regarding finals and pre-finals (in which no planning nor events should occur during those weeks), went over details regarding officer transitions, attendance roster sheets, and the feedback survey for club leaders. The Canvas page that has been previously mentioned is expected to be uploaded in January after further refinements.

2. Met with Vice President Ramprasad to discuss potential initiatives for Spring 2022, and Senator Guajardo will be reaching out to other Senators for possible collaborations.

1. a. INFORMATION ITEM: CSSA November Plenary (E. Quinonez/A. Rugerio)

- o Cal State DC Scholars application deadline is November 29 for the Summer 2022 session, and is an internship open to all majors. Accepted students should expect to pay for 2 summer classes, air fare, and housing costs; the internship is a paid opportunity.
- o Provided a QR code that directs individuals to a document from CSSA on the Legislative process which shows the previous legislations that CSSA has supported. The document also provided deadlines, a preview of January 2022, and upcoming issues that will be relevant to CSSA.
- o The Board of Directors proposed their 2022-2023 calendar and discussed how to hold CSUnity in the future (such as alternating each month between meeting online or in-person). The Board also announced they will be utilizing a new software (OnBoard) for their virtual Plenary meetings.
- o Provided a QR code for Policy agenda and their priorities and subsequent goals. Their 4 priorities are listed, and the individual goals are listed on the linked document.
  - Priority 1 is to ensure students have access to baseline services and resources to enable educational accessibility and equity.
  - Priority 2 is to ensure student health and safety are prioritized to enable belonging on campus.
  - Priority 3 is to ensure the academic success and holistic educational experience of all students.
  - Priority 4 is to ensure systemwide environmentally sustainable policies and practices.
- o The written comment system will be allowed regardless of the meeting being online or in-person (Note: there will be no hybrid model, so if individuals cannot attend an in-person meeting, this is the primary way to provide feedback). Public comment is due by 5:00pm the Monday before each meeting.
- o Reminded Senate that the Student Trustee Application is open until January 31 at 5:00pm.

b. INFORMATION ITEM: Lobby Corps Presentation (E. Quinonez/A. Rugerio)

- o Lobby Corps is a program under ASI Student Government which commits to ensuring the student voices on campus are heard at a local, state, and national level. Every school's

Lobby Corps is unique, and at CSUCI their work starts in the Spring whereas other campuses may have it year-round.
