  - a. Legislative Reports:
    - i. M. Vargas- Senator of Sustainability and Technology
      - 1. No report.
    - ii. A. Pogosian- Senator of Commuters and Transportation
      - 1. There will be a University Police Advisory meeting on May 3<sup>rd</sup> via Zoom.
    - iii. L. M. Ruiz- Senator of Veterans and Non-Traditional Students
      - 1. There is the first unofficial meeting of CSUCI Veterans Club where they hope to be approved for next semester and it is open to all (veterans and allies).
    - iv. A. Kroll- Senator of Social Justice
      - 1. The Title IX interviews have concluded and campus will soon find out who the new hire is, and also stopped by Denim Day.
    - v. S. Chandrasekaran- Senator of Alumni and Graduate Students
      - 1. None.
    - vi. S.S. Chamarthy- Senator of Academic Affairs

- Attended the May 2<sup>nd</sup> Academic Senate meeting where they were informed that a policy for priority registration for dependent children has passed, talked about unit bylaws for nontenured track faculty, and there is lot of pending agenda. The Committee has moved to have a special meeting next on May 9<sup>th</sup>.
- b. Executive Reports:
  - i. President Report (I. Tolteca)
    - The last ASI Elections Council of the semester was April 27<sup>th</sup> where they talked about recommendations for next year's council, the DHR Implementation team met on April 28<sup>th</sup>, worked Admitted Dolphin Day on April 29<sup>th</sup>. Upcoming, the last ASI Board of Directors meeting of the semester is May 4<sup>th</sup> and will be at 7:40am via Zoom, SRPC will meet on May 5<sup>th</sup>, and the final CSSA Plenary of the semester is May 6<sup>th</sup> and 7<sup>th</sup> where they will elect the final Executive member for the team.

    - Is working on transition report, met with the CSU Educational Seminar to talk about a Transfer Student Reform Act, which is a bill to make the transfer process more accessible, APPC is having their last meeting of the semester on May 4<sup>th</sup> to choose the next chair, Preparedness Working Group is meeting on on May 5<sup>th</sup>, and May 6<sup>th</sup> and 7<sup>th</sup> will be travelling to Bakersfield for the final CSSA Plenary of the semester.

      - 3. Senator Chamarthy agreed that there is not enough information to students in regards to Academic Senate, and expressed that most of the discussions happening are for students but they have no direct say due to not being aware or involved.
