- a. DISCUSSION ITEM: Resolution Opposing the CSU Multi-Year Tuition Increase Proposal (*D. Navarrete / J. Guajardo / A. Garza*)
 - i. Presented the Legislative Branches' first draft on opposition to the tuition increase.
 - ii. Friendly Amendments were made in regards to grammatical errors and formatting.
 1. J. Guajardo added semicolons, changed a footnote, and corrected spelling mistakes.
 - iii. L. LaGarde mentions demographic is diverse in mentioning who will be impacted.

- c. DISCUSSION ITEM: Student Housing Operation Concerns (*A. Garza*)

- i. Main avenue to gain feedback through surveys about overall safety on campus as students living onsite. Last year issues regarding the mountain lion, cleanliness (bed

bugs, fleas, couches not being cleaned by housing faculty), and transparency about how these facilities are being maintained.

1. The Senate asked if there is a way to see how complaints are organized: excel sheets per buildings, or work orders. The Senate then mentioned students getting charged for housing “damages” despite housing not explaining what damage they are being charged for. Ant infestations were also brought to housing, to which students were told to use Raid, despite ant issues persisting. Additionally, fire alarms are unreliable as they go off accidentally, sometimes multiple times a day.

Point of Clarification: A. Block-Weiss recommends A. Garza to be strategic about using unbiased questions when surveying general student body.

- ii. Time yielded by L. LaGarde to H. Alatorre: As a senator you can go directly to the top of this issue by meeting with HRE. The Vice President may attend the meeting with you to further establish it as a Student Government matter, not employee HRE meeting seeing as A. Garza is employed by Housing. Anecdotal evidence can be brought up.
 - iii. Time yielded to D. Navarrete: Stated she reached out to Gary Gordon but they never responded. Planning to follow up with him to schedule meeting with J. Guajardo. Since then, they have received additional housing concerns: students unsure of how to wave fees and never received surveys about housing experience.
- d. INFORMATION ITEM: CSSA Plenary Meeting (*D. Navarrete, A. Fox*)
- i. CSSA Agenda was presented and will be available on the Student Government website and with Senate Packet.
 - ii. The Senate asked how are we standing on Native Graves Protection and Repatriation Act (NGPRA) at Channel Islands? Director Fox responds that CI is not doing well from his understanding and will update the following Senate meeting after CSSA Plenary.
 - iii. Time yielded by A. Clarke to H. Alatorre: Clarification on what CI has not done well on- CSU efforts to comply to NAGPRA in regards to repatriations as remains and cultural: Only 1% of remains and cultural items has been repatriated. There is a President’s Chumash Advisory Council (PCAC) at Channel Islands.
