 - Report was submitted mid February
 - Next big event is the campus visit
 - o CSUCI Institutional Report can be found on Accreditation Website
- Searches in Need of Faculty
 - Associate Dean for School of Education
 - AVP for FASE
- Academic Reorganization
 - Conversations between Academic Senate Officers and Provost
 - Important to Academic Senate Officers that these conversations are transparent
 - Reorganization with Chairs and Deans
 - Academic Senate Officers have been reassured that eliminations or any programs or degrees will not be considered

- Changes to GE
 - CSU Board of Trustees is weighing changed to Title V that will modify CSU GE requirements to reflect those in the recently developed CalGETX transfer curriculum recent created to provided students with a unified pathway to transfer from California Community Colleges to the CSU or the UC.
 - That pathway reduces the GE required by students and provides the new framework for CSU GE
 - o If and when the BOT makes this change to Title V, campuses will need to adjust their catalogs quickly
 - More information and updates will be provided when available

- New Academic Programs and the (Academic) Senate Budget Committee
 - (Academic) Senate Budget Committee is very close to having a framework for evaluating resource needs of new academic programs
 - Draft of this framework will be shared with Academic Senate as an information item
 - Academic Senate Executive Committee is continuously asking the Provost and President (Dr. Yao), for information on how they are going to organize the launching of new academic programs as their "long form" is approved at Academic Senate

- Honors Convocation
 - Mentioned that the committee met with the provost on 2/22 and worked on a proposal that detailed estimated number of participants, possible locations for it to take place, and possible dates (possibly a week or two prior to graduation)
 - Mentioned that some programs already do something to honor their students, but wants to support those that don't have something to honor their programs
- Academic Senate Meeting Times for Fall
 - Will remain on Tuesdays at 2:30pm

1st Reading: Policy on Office Hours (FAC)

- Serves as a baseline for people to follow
- Continues to gather feedback, questions, and comments
- Feedback shared by Academic Senators
 - o If a class is on MW, have office hours on a Monday or Wednesday
 - Point #5 faculty are expected to meet in person and meeting with students outside office hours is still office hours
 - Students prefer meeting 1-on-1
 - Concerns about modality for faculty who do not have physical offices
 - One example shared is to create a survey and ask your course/students specifically when office hours work best
 - Recommends to not have the policy prescriptive as it will have a higher chance of being amended

1st Reading: Policy on Office Hours (FAC)

- Continued Feedback shared by Academic Senators
 - Office hours need to be consistent and not changing so that students can find predictability
 - Consider accessibility such as commute times
 - #1, 2, 3, 6 should be a policy and enforced, the rest are best practices / recommendations
 - Student Government President Navarrete thanked the FAC for supporting students through this office hours policy by making it clear professors should host regular office hours. She mentioned how sometimes Professors say to reach out to schedule a meeting in their syllabus, but response time can vary.
