

- Student Government President, Vice President, Director of Operations, and Senator Clarke attended in-person
- Student Government Senator Ruiz and Senator Iglesias attended online
- President Navarrete and VP Guajardo provided a brief overview of their presentation to Academic Senate
  - Link to Presentation, Academic Senate Chair suggested adding presentation to their Meeting Minutes
- Feedback/Questions Received:
  - Most successful implementations are tied to gradebooks and Canvas
  - Technical infrastructure currently exists
  - Senators inquired if it would be similar to a CARE Report answer is no.

# Takeaways 12/05

### SRTs and Policies (ASI, Student Government)

- Discussion arose during a conversation between Student Government President, Vice President, Provost and AVP DeGraffenreid
  - Student Government raised the concern that the deadline does not allow enough students to fill out their SRTs
  - Provost shared that the deadline is written in the Policy of SRTs
- Student Government inquired what the process would be of extending the deadline
  - Policy hasn't been review in almost 10 years
  - Encourages Lydia Dixon (from Faculty Affairs Committees)
  - Policy change is within the control of Academic Senate
  - Lydia Dixon will connect with SG President Navarrete to continue this discussion along with FAC's priorities for Spring

- Student Government President & VP have expressed interest

### Update on ASI (SG) & SAPP Resolution

- Shared that SAPP has expressed interest in co-sponsoring a joint Resolution with Student Government in support of an Early Alert System added as their first item of business in Spring
