### 7) Outstanding Business:

- DISCUSSION ITEM: Resolution in Support of the Implementation of an Early Alert System for High D/F/W Courses to Increase Student Success and Retention (A. Clarke, D. Navarrete, J. Guajardo)
  - i. Draft will be included in Senate Packet and uploaded onto the Student Government Website.
  - ii. Recommended Amendments to the Resolution from the Student Academic Policy Procedure Committee (SAPP) committee:
    - 1. Separate the desire to have it and the implementation. Fix the definition to clarify the interventions.
    - 2. Clarification as mentioned on the CSUCI Website about D/F/W: high-Drop, Fail, or Withdrawal.
    - 3. Encouraged the inclusion of creating a Taskforce for the implementation of an Early Alert System.
  - iii. Senate inquired about the organizations that will be collaborating on this initiative.
  - iv. Presenter mentioned that it is important to separate the definition between the CARE team and an Early Alert System to ensure people are not confusing the two, as one is academic and another is wellness based. Academic Senate had similar concerns as they believed the CARE reports included aspects of the Early Alert System.
  - v. Senate inquired if all Departments should be included. Presenter mentioned it can get complicated if all campus Departments are included, however, all academic disciplines are included.

- vi. Yield of Time to Advisor Block-Weiss: You don't have to plan out the resolution A-Z, the core of the intention is to be communicate the idea. In the end there may be alterations.
- vii. VP Guajardo and President Navarrete will be using the framework and ideas from this resolution to create and propose a resolution to Academic Senate.
- b. ACTION ITEM: Resolution in Support of the Implementation of an Early Alert System for High D/F/W Courses to Increase Student Success and Retention (A. Clarke, D. Navarrete, J. Guajardo)

- d. DISCUSSION ITEM: Student Government Happy Hour Care Packages (D. Navarrete, J. Guajardo)
  - i. Update: items have been ordered and are being organized. Still working out details regarding distribution of the items and activities that will be available during the event.
    - 1. Items include sensory stickers, snacks, gum, mints, candy, etc.
    - 2. Sign-in sheet was sent out and will remind Senators a day before.
- e. INFORMATION ITEM: Update Student Concern Regarding Faculty Professionalism in Courses (D. Navarrete, J. Guajardo, A. Clarke, L. LaGarde)
  - i. Update from last week's Senate meeting as they received a response. Response questioned what monitoring this situation would look like, and how academic progress for students will be preserved. Learning community course offerings have been scaled up. VP Guajardo questioned how the faculty members qualifications about the learning community would be vetted prior to their involvement. Verbiage such as that used may cause first-year student to feel abandoned and unsupported, especially if asked to "work or quit" as the professor mentioned to students. Only option left to Drop, Fail, or Withdrawal.
  - ii. Senator Ruiz recommended this information should be provided during orientation as this reflects on student grades and their understanding about how to approach this situation if students are feeling stuck.
  - iii. Yield of time to Cindy Derrico: Impressed with the request and advocacy on behalf of Student Government. Students can search Student Grievance Procedure on the CSUCI website: simple methodology if students have concerns. The procedure directs you to the chair and administrative side, from an academic perspective one would then go to the Provost. If a student believes they've been graded unfairly, grade appeal is available at the end of the semester.

#### 8) New Business:

- a. DISCUSSION ITEM: Safe Parking for Commuter Students (A. Clarke, A. Parks, D. Navarrete, J. Guajardo)
  - i. Supplemental material will be included in Senate Packet and uploaded to the Student Government website. This safe parking proposal would allow student commuters to park overnight on campus. Other campuses have had similar initiatives for student experiencing housing insecurity. This proposal clarified that those parked will be monitored by the CIPD. Senator Parks has met with the CIPD to propose this idea and at the moment it seems well received as CIPD said they are open to the idea.
  - ii. Senate inquired how the parking fees would overlap with this. Presenters clarified the implementation details have yet to be discussed. Another concern mentioned is that the CIPD is not very student friendly. Presenters mentioned this could be an opportunity to bridge student and police/law enforcement gap. Resistance from some Departments was brought up but follow up will continue. Resolution in writing is in the works.
- b. DISCUSSION ITEM: Student Government Fall 2023 Summary (D. Navarrete, J. Guajardo)
  - i. Presentation will be included in Senate Packet and uploaded onto the Student Government Website.
  - ii. Yield of Time to Advisor Bock-Weiss- Swearing in ceremony is conducted in collaboration and support to Elections Council subcommittee.
  - iii. Senate shared they felt they had not been introduced as Senators in previous years and expressed sentiments from last year's ceremony of feeling unrecognized.
  - iv. Yield of Time: current executive team plans the swearing in ceremony, historically has been done solely for the President and Vice-President, but this can be changed by current administration.
  - v. Senate clarified they wish to be recognized as incoming and outgoing senators in the introduction of the swearing in ceremony. Presenters mentioned they have seen inaugurations and will look into ideas to incorporate in the Spring 2024 semester.
