- 8) New Business:
 - a. DISCUSSION ITEM: Covid 19 Updates (Associate Vice President of Student Affairs for Campus Life and Dean of Students, C. Derrico) [Time Certain: 10:00 AM]
 - i. During their presence, Dean of Students Derrico answered various questions regarding their role, the upcoming return to in-person classes, and how to best navigate student support. Below are summaries of the questions asked and the response provided.
 - Vice President Ramprasad asked what it was like being the Dean of Students and their role throughout the COVID-19 protocols. The response was that their overall role is focused on the bigger picture for students throughout the pandemic.
 - President Rugerio asked for possible resources to help ease any anxiety amongst students' return and it was mentioned that on the CSUCI website, the blue banner at the top of the page would take individuals to a landing page with all information regarding COVID-19 on campus (including a Q&A, statistics, information for students and employees, and the campus communication catalog).
 - 3. Director Quinonez asked how the campus is best monitoring students to adhere to the guidelines, to which Dean of Students Derrico responded it's important to provide the proper avenues for students to be able to follow the rules, and to make sure they feel empowered to hold other students accountable. If a student notices a peer is not following the proper protocols, the student can address them themselves, they can be reported to the faculty member for the class, or to the Dean of Students office.
 - 4. Senator Mosco asked about the possible plans for is there is a large surge of positive cases at any point; Dean of Students Derrico responded that the best person to ask would be the Director of Environment, Health and Safety Joyce

Spencer, but added that the University is working closely with the county of Ventura to ensure proper responses and plans of action.

- 5. President Rugerio reminded Senate that Counseling and Psychological Services (CAPS) is an important resource for students to be able to use during these unprecedented times, and that the emails from President Yao include other resources for students.
- b. INFORMATION ITEM: How to Apply to Lobby Corps (E. Quinonez/ A. Rugerio) [Time Certain: 9:20am]
 - i. Director Quinonez gave a brief presentation illustrating how to apply for Lobby Corps via CISync (see provided presentation). The application (also available on the Student Government LinkTree) closes on February 6 at 11:59pm. The upcoming CI View Weekly on Friday will also include a flyer and a link to the application, and all students who pay ASI fees received an email on January 27 which includes information on Lobby Corps as well as the direct link.
 - ii. Lobby Corps is a group of students who advocate for issues regarding higher education, and any interested student can reach out to President Rugerio (<u>aurora.rugerio235@csuci.edu</u>), Vice President Ramprasad (<u>vaishnavi.ramprasad677@csuci.edu</u>), Director Quinonez (<u>emily.quinonez151@csuci.edu</u>), or Senator Guajardo (<u>jazmin.guajardo557@myci.csuci.edu</u>) for more information on their experience being apart of it.
- c. INFORMATION ITEM: CSSA January Updates (E. Quinonez/A. Rugerio) [Time Certain: 9:40am]
 - i. The most recent CSSA was held during the second week of January, and it was announced that the rest of the semester's events would be online. Updates for the Systemwide Affairs Committee include the CSU Standardized Exams and Admission Requirements (SATs an ACTs) and it's potential for permanent removal and possible alternatives; Director Quinonez will be doing more research on the subject to give an informed presentation, but questions are encouraged to be emailed to them so they can get answers. Updates from the Legislative Affairs Committee include updates to a Senate Bill regarding Foster Youth Support Programs, AB 1602: Student, Faculty, and Staff Housing, Student Housing Revolving the Loan Fund Act of 2022, and action items for AB (Medina/McCarty/Leyva)-Cal Grant Reform, and AB 1625: Trustees of the California State University: Student Members. Updates from the Board of Directors include approval of the 22-23 CSSA Calendar, approving the Legislative Affairs Committee bill recommendations (AB- Medina/McCarty/Leyva Cal Grant Reform and AB 1625), and announced that CHESS will be virtual.
