  - ii. Senate inquired about the Multi-Year Tuition Increases and the Consumer Price Index. Presenters addressed this inquiry by mentioning Assembly Bill 3112 would intend to limit the amount that institutions can raise tuition based on Consumer Price Index.
    - 1. Further inquiry included if the CSU Tuition Increase would go into effect despite continuous protests.
    - 2. The Board of Trustees voted to approve the CSU Tuition Increase in September, which will take effect in Fall 2024.

  - iv. Advocacy Included the following topics and legislation:
    - 1. Cal Grant reform due to limiting students on age and nontraditional students was mentioned.
    - 2. General Higher Education funding was also discussed, which has currently been deferred for a year. Education Facilities Bond was also on list of advocacy efforts.
    - 3. Co-Sponsored Legislation includes AB 1160 and AB 2458
    - 4. CSSA Supported Legislation includes AB 810, AB 2407, AB 2586, AB 2608, and AB 3112
- g. INFORMATION ITEM: Academic Senate Summary (*D. Navarrete, J. Guajardo, E. Hernandez*)

  - ii. Point of Clarification from Advisor Block Weiss: MPP acronym- Management Personnel Plan, in general is a state side classifying term to account for staff that is at will and not unionized, most commonly administration.
