### For Review: What is CSSA?

The Cal State Student Association (CSSA) Is a student-led organization strives to improve the lives of California State University (CSU) students by advocating for student needs and engaging students in systemwide, state, and federal higher education policymaking.

The California State Student Association, also known as the Cal State Student Association, is a nonpartisan, nonprofit student organization founded by CSU student body presidents in 1959. CSSA is led by, funded by, and represents the over 482,000 students of the CSU.

### For Review: What is CSSA?

All California State University (CSU) students are represented by the Cal State Student Association (CSSA) on issues related to higher education policy making and on issues that affect students at a systemwide level.

CSSA's governing members are representatives from the 23 campus Associated Students (Inc.) organizations. CSSA relies on campus ASI's to appoint their campus representatives.

### What are **Plenaries**?

CSSA plenaries are meetings of the board of directors and committees. Plenary meetings are open to the public in accordance with Gloria Romero Open Meetings Act of 2000.

Meetings take place monthly (with the exception December and June) at a location decided by the governing board each July. This year CSSA meets hybrid, one month virtually, the next in person.

### **Campus Connections**

- Each plenary meeting commences with campus connections where a handful of CSU's are paired up with a CSSA executive member to discuss on going concerns/efforts on their campuses
- We have been paired up with CSUN, Fresno State and CSU Stanislaus
- Primary conversation was on student support from faculty and administrators in a post online environment and how cssa can help advocate for more support

## **Systemwide Committee**

- DISCUSSION ON DINING SERVICES: Vice President Samaniego (of CSSA) led a discussion regarding student experiences with campus dining. Each campus provided their perspectives, concern and needs on campus dining options (varied).
- INFORMATION CSU POLICIES: Vice President Samaniego presented information on the Committee's review of the CSU's Student Participation in Policy Development policy.
- Will vote on it at this weekends plenary!

Policy ensures recognizing ASI leaders as official student voice as campus and whom Campus President goes to, ASI can select any student to serve as rep (Policy is available to view under Jan plenary minutes for syst. committee)

#### ITEMS TABLED FOR FEBRUARY PLENARY

- **BUDGET AND TUITION PRESENTATION**: President Malhotra and Vice President Samaniego will present information on the 2023/2024 CSU Budget and Tuition Proposal.
- **PRESENTATION JANUARY BOARD OF TRUSTEES:** Vice President Samaniego will provide a January 2023 Board of Trustees update.

### **Executive Committee**

- Back at CSUnity in september, there was a mention of an opportunity for a group of CSSA members and students from their campuses to participate in the Higher Education Student
  Coalition attended by the three statewide student associations are Cal State Student Association (CSSA), Student Senate for California Community Colleges (SSCCC), and University of California Student Association (UCSA).
- The Higher Education Student Coalition is a robust joint campaign to Fix Financial Aid. The success of this endeavor has encouraged the student groups to continue their collective advocacy efforts and identify additional issues impacting college students and their ability to succeed that they would like to focus on fixing together

## **Executive Committee cont.**

- On October 27 and 28, 2022, the three statewide student associations held a Higher Education Student Coalition (Coalition) Convening in Sacramento, California.
- The Convening focused on three policy areas that statewide student association leadership believes impact many students across the three segments: (1) College Affordability, (2) Transfer, and (3) **Resource Accessibility & Equity.**
- It concluded with participants recommending specific policies across these areas for the Coalition to pursue over the next two to three years, with details to be determined after the statewide student association boards have approved the policy agenda. (full policy available in public agenda)

### **Finance Committee**

- Specific budget numbers/charts, agenda, minutes etc. are **available to public** at CSSA website under documents section -> **Budget and Finance and/or Plenary finance committee agendas** minutes!
- Update on spending statements from November and December
- Conversation of impact of Budget cuts on Organization occurred here, CSSA is funded by a student fee called the **STUDENT INVOLVEMENT & REPRESENTATION FEE (SIRF)**

## **Finance Committee**

- SIRF is a \$2 fee assessed twice a year to all California State University (CSU) students in order to fund the Cal State Student Association.
- Initiated and developed by CSSA, SIRF creates a more independent and effective statewide student association with the main objective of expanding CSSA's efforts to serve all CSU students. The fee creates direct accountability of CSSA to the students it serves by giving students a choice to participate (or not) in SIRF and supports the organization that represents their body.
- Enrollment drop -> Budget cut -> less SIRF funding available for CSSA
- Discussion on reallocation of internal fees and investments occurred

### **Student Trustee Committee**

- Updates on promotion offers for student trustee application (during the plenary only one individual had fully applied, 13 had begun application).
- Chair Alvarez had been working on outreach of the individuals who had begun to ensure applications were turned in by deadline
- Application closed on January 30th at 5:00 pm
- Presidents are being asked to serve on interview panel that will occur February the 25th (a Saturday).

### **Internal affairs Committee**

#### COMMITTEE MEETING POSTPONED FOR FEB PLENARY
