A RESOLUTION IN SUPPORT OF GOVERNOR BROWN'S TAX INITIATIVE PROPOSAL

WHEREAS. The mission of California State University Channel Islands (CI) Student Government (SG) is to place the students at the center of our educational experience by leading with integrity and selflessly serving the students and the University on a local, state, and national level; and CI SG serves as the official representative voice of CI students; and WHEREAS, CI SG is an entity of Associated Students of California State University Channel Islands, WHEREAS, Incorporated (ASI); and The California State University (CSU) has recently faced substantial budget cuts from the state, WHEREAS, including a reduction of \$750 million in 2011-2012 alone; and WHEREAS, In addition to the state budget cuts, the CSU has also faced a series of tuition and fee increases since 2001, raising the cost of undergraduate attendance from \$1,428 in 2001 to an estimated \$5,970 in 2012¹; and Every \$1 invested in the CSU yields a \$5.43 return back to the California economy, sustains WHEREAS, almost 150,000 jobs, and provides a majority of graduates in key economic areas such as agriculture, medicine, criminal justice, and education²; and WHEREAS, The state of California currently has a \$15.7 billion deficit; and The current state budget assumes the passage of Governor Brown's Tax Initiative in order to WHEREAS, balance the budget; and WHEREAS, The California higher education systems face automatic "trigger cuts" of \$250 million for the both the CSU and University of California (UC) systems, and \$548.5 million to the California Community College (CCC) system if voters do not approve the Governor's Tax Initiative in November³; and The California budget also includes an increase in funding of \$125 million to the CSU and UC in WHEREAS, 2013-2014 if the Tax Initiative is approved and tuition and fees are maintained at 2011-2012 levels for the 2012-2013 academic year; and The California State Student Association (CSSA) has approved a resolution in support of Governor WHEREAS. Brown's Tax Initiative; and WHEREAS, The CSU Board of Trustees has officially endorsed the Governor's Tax Initiative Proposal⁴; therefore be it
