A RESOLUTION REQUESTING RE-EVALUATION OF THE EXISTING CI CAMPUS SMOKING POLICY

WHEREAS,	The mission of California State University Channel Islands (CI) Student Government (SG) is to place the students at the center of our educational experience by leading with integrity and selflessly serving the students and the University on a local, state, and national level; and
WHEREAS,	CI SG serves as the official representative voice of CI students; and
WHEREAS,	CI SG is an entity of Associated Students of California State University Channel Islands, Incorporated (ASI); and
WHEREAS,	The adverse health effects from cigarette smoking account for an estimated 443,000 deaths, or nearly one of every five deaths, each year in the United States and have been linked to many other diseases including cancer ¹ ; and
WHEREAS,	CI currently has an Administrative Policy on Smoking on Campus (Policy FA.31.013) ² that states: "Smoking is only allowed in locations which are at least 50 feet away from any structure on the campus including bus stops and outdoor dining areas. At designated outdoor recreational areas, smoking is prohibited within 50 feet of the playing surface"; and
WHEREAS,	In the 2013 ASI Elections, the CI student body stated that they are in support of CSU Channel Islands to become a smoke-free campus ³ ; and
WHEREAS,	The University of California has instituted a system-wide ban on smoking, becoming smoke-free on all campuses by 2014 ⁴ ; and
WHEREAS,	California State University Fullerton will become a smoke-free campus effective August 1, 2013 ⁵ ; and
WHEREAS,	Some campuses of the CSU system have established designated smoking areas, prohibiting smoking outside of such designated areas ^{6,7} ; and
WHEREAS,	San Francisco State University has implemented citations for those found smoking outside of their designated smoking areas ⁷ ; and
WHEREAS,	While electronic cigarettes are marketed as not having second-hand smoke associated with their use, there is limited evidence substantiating such claims; and
WHEREAS,	CI SG believes that it is imperative that CI maintain a healthy learning environment that promotes both good academic habits, as well as good health habits; therefore be it
RESOLVED,	That CI SG requests that the CI campus faculty, staff, and administration re-evaluate the current policy on smoking; and
