Discussion

Senator Alexander See

i. The problem with AB 656 that I have is that most of our oil in California comes from the Santa Barbara Channel and the oil infrastructure out there is getting old and outdated and it cannot be replaced because of restrictions on any new offshore oil developments. I believe that the platforms in the channel will be closed in ten years and our funding will dry up. The reason why this tax is successful in Texas and Alaska is that new offshore developments are allowed and provide a stable amount of revenue.

### Senator Jonathan Neira

i. I don't approve of the word 'stable' in line 38. I do not think this is a stable source.

### President Kevin Schallert

i. This isn't the only source there will ever be. We can move to strike that word out. The language is saying that this tax should not supplement the need from the general fund.

# Senator Mackenzie Garcia

I. Are there any other ideas that have been thought up?

### President Kevin Schallert

i. We have not talked about any other sources, but possible Prop 98.

# Director of Statewide Affairs Katelyn Rauch

i. There is a competing bill for the oil and gas severance tax that would be put into the general fund.

# Vice President Lauren Pollack

i. This is a Resolution in support of CSSA educating the CSU community about AB656.

# President Kevin Schallert

i. For this sort of resolution, the Resolved are good if from all CSU's, but the clauses need to be made accurate. This is CSUCI Senates' word.

#### Senator Jonathan Neira

i. I want to strike out the word 'dedicated' and 'stable'.

### Vice President Lauren Pollack

i. Is the Resolved okay?

#### Senator Alexander See

i. I'm abstaining because this bill has a major flaw.

### Senator Brandon Clark

i. The bill is short-sided but it will help. Within that time, the state can pull out of decline and provide money in other ways.

### President Kevin Schallert

i. I want to make sure everyone knows what the Resolution is stating. It just says we support CSSA supporting educating students and others about AB 656.

# a. Budget: State, University & Internal

- i. \$60.6 million in enrollment growth
- ii. \$305 million in the proposed budget; last fiscal year had a one time cut of \$305 mil.
- iii. Proposed change to constitutional language saying prison should not receive more than 7% of the state fund. Education should receive no less than 10%.
- iv. President Kevin Schallert: Historically, what the governor proposes is normally what we get. We need to work even harder to make sure we keep that money to get fees reduced and to have more resources for the University. Make Higher Education more of a priority.

### **b.** ASI Mission statement

- i. The Mission Statement is the same, but the Student Union Mission Statement had the bullet points changed to commas.
- ii. Everything in the Mission Statement is something we should strive for and become more familiar with.
