a. DISCUSSION ITEM: ASI Elections- Joint Ticket System (*A. Block Weiss*)

- 1. Advisor Block-Weiss shared with the Senate that historically the ASI Elections have had the ASI Student Government President and Vice President run on a joint ticket and students vote for or not the joint ticket. Upon benchmarking with other CSU Student Government's, it was found that at least half have those positions run separately. The feedback being requested of the Senate is if they feel this is a good idea or not, as the ASI Election Code is being presented to the ASI Board of Directors next week for potential edits. Advisor Block-Weiss also shared that feedback from the Executive team indicates that they believe this to be a good idea and would allow more students to potentially run for office. The Senate shared with Advisor Block-Weiss that they also believe this to be a good change in the code. This feedback will be shared with the ASI Board as they consider this edit.
