 - a. DISCUSSION ITEM: Student Government Voter's Registration (E.Conde, R.Banda)

 - a. DISCUSSION ITEM: ASI Fee Referendum (H. Alatorre)
 - 1. The ASI Fee is a mandatory, student-led fee that supports Student Government, clubs, and campus programs. Changes to this fee can only happen through a student referendum.
 - 2. Due to reduced enrollment, funding has declined since 2020, thus all ASI funding allocations have decreased over time.
 - 3. The Student Fee Advisory Committee approved moving forward with this referendum, and ASI is actively informing the student body about a proposed increase to the fee and its impact. Visit asi.csuci.edu/asireferendum.htm
 - 4. The current Fee is \$75 per semester. The proposed increase would be an added \$20 per semester fall 2026, then an added \$20 per semester in Fall 2027, bringing the total fee to \$115 per semester/ \$230 per year by 27-28, followed by nominal Higher education price index (HEPI) percentage increases for inflation thereafter.
